**RE: Hearing Request**

Dear Representatives Skelton and Hunter:

Last month, our organization unveiled a video tape of interviews with a number of senior military and civilian members of the U.S. Army and the U.S. Air Force – some of whom appear in uniform, during the duty day, inside the pentagon – promoting an organization called the Christian Embassy and advocating spreading their view of Christianity throughout the armed forces. We are deeply troubled by apparently unchecked violations of the religious liberty of junior military personnel and are writing to ask that the House Armed Services Committee convene hearings on the circumstances surrounding the creation of the videotape promoting the Christian Embassy and its fundamentalist Christian principles, and on incidents of widespread religious proselytization in the military. Attached please find a transcript of the Christian Embassy video and a report on the pervasive religious freedom violations in the U.S. military.

The Christian Embassy video implies that military personnel, including commanders, may be attempting to change or coercively influence the religious views of subordinates in violation of stated military core values and, likely, the U.S. Constitutional guarantee of separation of church and state. We believe that Congressional oversight and inquiry into this pervasive proselytization is necessary to protect the religious liberty of our country's honorable and diverse armed forces.

The Military Religious Freedom Foundation is dedicated to ensuring that all members of the United States Armed Forces fully receive the Constitutional guarantees of religious freedom to which they and all Americans are entitled. We are poised to help in any way we can to get this important issue addressed. Please don't hesitate to let us know how we can be of service.
