













-  **May 2021 – MRFF Action Leads to Immediate Response and Review of Religious Content Policy by U.S. Army:** The May/2021 issue of At Ease magazine included a cover photograph of a traveling memorial created by the private organization Veterans & Athletes United (VAU).
-  **April 2021 – MRFF Forces Immediate Removal of DoD Website Article Seeking Apology from Jews for Killing Jesus:** In an article for DailyKos, MRFF Senior Research Director reported on an article containing a blatantly anti-Semitic screed posted to the ‘News’ website.
-  **April 2021 – MRFF Quickly Forces Immediate Removal of Anti-Semitic “Proud Christian” Section Chief:** After reading about a Colorado state district court judge recently resigning after acknowledging the use of bullying racist statements with employees that were often cloaked as innocent ‘fact-finding’ questions.
-  **April 2021 – MRFF Intervention Immediately Ends Practice of Lowering U.S. Flag in Shockingly Sectarian Religious Tribute:** Five active-duty Christian U.S. Navy Sailors contacted MRFF when they found themselves under orders to lower the U.S. Flag in a blatant religious tribute to Jesus Christ.
-  **April 2021 – MRFF Assistance Leads to Immediate Resolution of Clients’ 6-Month Attempt at Religious Accommodation:** An active-duty Muslim U.S. Army Soldier attempted to work with another Muslim Soldier to request religious accommodations for observing their faith during the month of Ramadan.
-  **March 2021 – MRFF Forces Town of Monument, Colorado Into Scared Attempt to Hide From Its Unconstitutional Promotion of Sectarian Religion:** On October 14, 2020, Ben Farrell of the Tri-Lakes Tribune/Colorado Springs Gazette reported on Michael Carlson’s Eagle Scout Project.
-  **March 2021 – MRFF Action Forces Immediate End to Distribution of “TRUMP IS STILL MY PRESIDENT” Bumper Stickers:** A representative of 5 active duty military members contacted MRFF President/Founder Mikey Weinstein after one of their NCOs (non-commissioned officer) was seen distributing extremely inappropriate bumper stickers to other staff members at the workplace while on duty.
-  **February 2021 – MRFF Intervention on Behalf of Client Leads to Immediate End of Christian Music Playing on Government Contracted Bus Service to Milwaukee MEPS:** MRFF was contacted via email on February 6, 2021, by a client regarding what was essentially a ‘captive audience’ situation for sectarian religious music being played on a U.S. Department of Defense contracted transportation service.
-  **January 2021 – MRFF Quickly Exposes Army National Guard Chaplain for Accusing Joint Chiefs-of-Staff of Sedition and Posting Numerous QAnon Style Political Conspiracies:** A MRFF client (and active duty Army Captain) emailed President/Founder Mikey Weinstein on January 28, 2021, requesting assistance with exposing and responding to a Chaplain in the Ohio National Guard.
-  **January 2021 – MRFF’s Swift Action Leads to End of Sectarian Religious Training Course at Air Force School:** An elite U.S. military school recently added an elective course, designed and taught by a faculty member, which was a bible study specifically of the Christian faith.
